**Focus and Purpose**

When I meet individuals outside of the educational profession ranks and when they find out my occupation, inevitably, schooling and how schools operate are the topic of conversation. The specific topics usually include: how schools are funded, testing of students, school policies, and most often, "how times have changed."

I am often struck by the frequency in which folks long for the "*good old days*" of how education and schooling "used to be." Usually, individuals make the comment to me, "When I was in school..." I usually walk away wondering if those individuals really mean they would like to return to those past moments and, more importantly, if they would want their children to be educated in that time and in those facilities.

We, as individuals, have a tendency to look back with fondness, thinking our childhood was better than it truly was. I suppose I am as guilty as anyone. We all have pleasant memories of what we did when we were in school, the teachers and coaches we connected with, or the activities in which we participated.

The truth of the matter is school has *evolved*, not *changed*, evolved. In my opinion, change is sudden, quicker, and takes place as a result of an immediate reaction to an event. The institution of public schooling, however, has evolved over many decades, in fact, over a century of time.

Consider the following example: As a student of educational history, I have learned first-hand how education has changed in its mere premise and purpose over time. In fact, Thomas

Jefferson once wrote in his notes on Virginia government, that education’s true goal was to “rake the genius from the rubbish.” In essence, to find the individuals who “deserved” an education and allow the rest to be governed by those who were truly educated—to discover who should be “learned” and who should serve as a “laborer.”

Today, your public school has a far greater purpose. The purpose for schools today is to strive to educate all students, to teach all students the importance of character, to teach all students what it means to live in a democratic society, to teach all students how to choose and prepare for an occupation, to teach all students the joy and pride in life-long learning, and many other goals—in short, to leave no “rubbish” or a child behind.

I truly do not long for a past time; I embrace with passion today’s educational mission and mandate, and I am proud of the students I work for, the staff I work with, and the community I reside in as we seek to accomplish this goal.

I hope you are looking forward to the start of the new school year as much as I. I hope each and every one of you can join me in the mission that is ours, to educate all, to care for all, and to celebrate all. We are truly blessed here in Cedar Cliff in our little school and in our special place—have a great year!

### **Immunization Information**

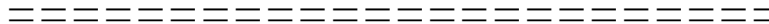
Incoming 7th graders for the 2022-2023 school year are reminded that they must show proof of the following immunizations before they may enter school. This coming fall, incoming 7th graders will be required to have documentation of 1 dose of **Tdap vaccine**. In addition, **Meningococcal vaccine** will also be required for the upcoming school year prior to entry to the 7th grade. Please check with your family physician if you have any questions.

Proof of these immunizations may be delivered to the office any time. This will need to be completed before students may enter school for the 2022-2023 school year. Once again, immunization documentation can be turned in beginning this week, through the summer months.

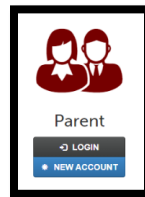
Seniors (those entering 12<sup>th</sup> grade) will need an additional Meningococcal Immunization (2 doses).

## **Emergency Phone System**

The Cedar Cliff Local School District utilizes the ONECALLNOW phone alert system for emergency/active response purposes or for weather alerts regarding school activities. ## ***District moves to New On-Line Student Registration Program***



The Cedar Cliff local School District will be moving to a new Student Registration program. The program “*Final Forms*” will now be the service whereby parents register students, complete all necessary Emergency Medical Authorization Paperwork, as well as complete all necessary Athletic Participation forms. There are several important items to note regarding this migration to the new system:

- We will not be “live” until August 8<sup>th</sup>. This is a week into the Fall sports season, so we will be slightly behind on paperwork for the sporting season. That makes it imperative that we get a good completion return once the district moves to the new program.
- We believe this new system will be superior to the program utilized in the past and will serve us well moving forward, however, many items may need to be newly entered into the system, please be patient if you have additional time to fill out forms in this first year of the transition.
- Online registration will begin August 8 for both new and existing students. You will receive an email from Final Forms giving you steps you will need to follow to step up your new account. Please make sure to also check your spam folder for the email from Final Forms.
- Cedar Cliff students will be receiving an email (grades 7-12) to update their information, as well. This will go to their email address from school.
- If families have any changes during the school year, please make certain to keep the system updated. The district will receive daily updates as changes are made for families.

## **Ohio School Immunization Requirements**

The state of Ohio requires children to be vaccinated against certain communicable diseases as a condition for school attendance. These requirements apply to both public and private schools.

Four common childhood vaccines —DTaP/DT Tdap/Td (diphtheria, tetanus, pertussis), MMR (measles, mumps, rubella), polio, varicella (chickenpox), and HEP B (hepatitis B)— are required to enroll in kindergarten. The first dose of the meningococcal vaccine is also required for entry into the 7th grade, with a second dose required for the 12th grade.

## **Billing & Payment**

There are a few options for billing vaccine services. CedarCare can bill as you go after each individual vaccine. We can also bill per claim to your insurance contract's pharmacy benefit manager, or we can put an invoice together and send it to you the next day. Dear Parent or Guardian,

Are you familiar with **Feed the 'Ville**? **Feed the 'Ville** is a weekly effort intended to help contribute to the nutritional requirements and development of our community's growing children. For students who participate, we provide a bag of food for them to take home each weekend that includes 2 breakfasts, snacks and 2 lunches at no additional cost to you or the school district. Mrs. Curlette and Mrs. Walker tell us the number of bags that are needed and will see that they are delivered to the students. This is handled in a discreet way so as not to embarrass the children. The information will be confidential! Only the school will have the names of students participating in this program.

The food items are either purchased or donated, then packaged and delivered by us to the school. Some items include easy-open, single-serve containers of meat, fruit, vegetables, pudding and microwaveable pastas, as well as snacks, granola bars, juice and milk. This program is meant to help provide your family with a dependable food source for your child during weekends, and help him or her benefit and learn from healthy eating practices.

It's a dual race to both enjoy the summer and get things completed before the school year begins. Well-child checks, sports physicals, and kindergarten screenings comprise much of summer bookings in Primary Care offices across the country.

**What is the difference between a well-child check and sports physical?** The American Academy of Pediatrics, the American Academy of Family Physicians, the American College of Sports Medicine, and other governing bodies have recommended that a preparticipation physical evaluation be a part of a student's health screening visit. Whether this visit is completed in a primary care office or at a screening center, expect questions to be asked such as history of concussion, family history of heart disease, anxiety, sleep, and nicotine use (vaping or cigarettes). In a sports physical setting, your child will be seen by a provider and form completed.

At a well-child check, your doctor's provider can be a little more comprehensive. Milestones are measured, immunizations checked to make sure all is in order, and additional interventions that keep your child healthy are ordered or discussed. With a focus on prevention and personalized care, many parents find that scheduling a well-child check allows the unique needs of their child to be assessed. The visit allows for forms turned in within the year to be completed by the office staff.

Children entering kindergarten also need a visit and likely some immunizations to complete the screening requested by the child's school. A well-child check ensures you and your child have a chance to review a growth chart and ask personalized questions about health concerns you or may have. Let your child know about immunizations just ahead of time and have some fun surprises to help celebrate growing up.

Call and schedule the visit most appropriate for your child. We would love to answer any questions that you may have. In an uncertain year, we want to help make the most of the summer memories you spend with your family and help be prepared for the year ahead.

### ***FYI--Back to School Tax Holiday!***

Ohio's sales tax holiday for back-to-school shopping will take place this weekend. Shoppers can make purchases without paying state sales tax for:

- Clothing items costing \$75 or less;
- School supplies costing \$20 per item or less; and
- School instructional materials priced at \$20 per item or less.

The holiday opens at 12 a.m. Friday, Aug. 5, and ends at 11:59 p.m. Sunday, Aug. 7.

### Notification Rights Under FERPA

You have a right to review your student's records by making a written request to the principal. The request will be honored within a reasonable period of time (no more than 10 working days). Exceptions to this time frame may be made, if necessary, during school vacation periods. Review of student records may be prohibited by a court order or other legally binding document.

Review of your student's file shall take place in the presence of the school principal or his designee. The request for review of your student's records will be placed in the student file as well as the date, time, and a list of individuals present at the time of the review.

A nominal copying fee will be charged if copies of student records are needed, and a receipt will be provided.

Parents and adult students have the right to amend a student record when they believe that any of the information contained in the record is inaccurate, misleading, or violates the student's privacy. A parent or adult student must request the amendment of a student record in writing and if the request is denied, the parent or adult student will be informed of his/her right to a hearing on the matter.

Parents have the right to inspect upon request any instructional material used as a part of the educational curriculum for their student. See Board Policy 2416 for the procedures for making such a request. Any parent or student who believes that the School District has failed to comply with the Family Education Rights and Privacy Act ("FERPA") or the Protection of Pupil Rights Amendment ("PPRA"), may file a complaint directly with the Family Policy Compliance Office, U.S. Department of Education, 400 Maryland Avenue, S.W., Washington, D.C. 20202-8520. This Notice will be transmitted to disabled parents and students or to non-English speaking parents and students in a format designed to accommodate their disability or in their native language.

## ***Route 72 Road Project Slated!***

We wanted to give everyone ample opportunity to plan and be aware. State Route 72 will see some work over the next few months in and around the towns of Cedarville and Clifton. The following was reported to the district by ODOT in terms of timelines and repairs:

- *Bridge work on the two bridges on SR72 on the south side of Clifton (between Water Street and Clifton Road). Construction on this phase will start July 18, 2022 and finish in early to mid-November.*
- *Resurfacing of SR72 from the Greene/Clark County line to just north of Turnbull Road. This phase will also the replacement of curb ramps along the project corridor. This phase is scheduled to begin in April of 2023 and be finished by the end of June.*

*During all phases of the project, traffic will be maintained, however there will likely be some delays as traffic will be down to one lane in the immediate area of work.*

- *For the first phase, temporary traffic signals will be used that will alternate the traffic in the area of the two bridges. This is a short work zone, so signal cycle times should be relatively short.*
- *For the second phase of the project, the work area will change daily. Flaggers will be used to maintain traffic for the resurfacing work.*

# Emergency Broadband Benefit

## What is it?

The Emergency Broadband Benefit is a temporary FCC program to help households struggling to afford internet service during the pandemic. The benefit provides:

- Up to \$50/month discount for broadband services;
- Up to \$75/month discount for households on qualifying Tribal lands; and
- A one-time discount of up to \$100 for a laptop, desktop computer, or tablet purchased through a participating provider.

## Who is eligible?

A household is eligible if one member of the household:

- Has an income that is at or below 135% of the Federal Poverty Guide lines or participates in certain government assistance programs;
- Receives benefits under the free and reduced-price school lunch or breakfast program;
- Received a Federal Pell Grant during the current award year;
- Experienced a substantial loss of income due to job loss or furlough since February 29, 2020; or
- Meets the eligibility criteria for a participating provider's existing low-income or COVID-19 program.
